- Currently valid passport: ID page + photocopies of all pages with visas, stamps and writing
- Currently valid “researcher passport talent” residence permit (or “researcher-mobility programme” residence permit) or Long Stay “researcher passport talent” visa with confirmation of validation
- Birth certificate specifying filiation
- If applicable, marriage certificate and/or birth certificate(s) of child(ren) specifying filiation
- 3 passport photographs meeting the specific standards required by the French authorities:

- Proofs of residence (less than 3 months old)
  - If you are a tenant: a copy of the rental agreement + a copy of an electricity, gas, landline telephone or internet access bill or a house insurance certificate OR an Attestation of Residence (if you live in halls of residence).
  - If you own the property where you live: a copy of the property deed/ certificate of ownership + a copy of an electricity, gas, landline telephone or internet access bill or a house insurance certificate.
  - If you are lodged by a private individual: a certificate of accommodation dated and signed by the host providing the accommodation + a copy of the host’s proof of identity + a copy of his/her own proof of residence (copy of rental agreement or property deed/certificate of ownership + a copy of an electricity, gas, water, landline telephone or internet access bill or a house insurance certificate.
  - If you live in a hotel: a letter dated and signed by the hotel manager and a copy of the most recent bill.
- Confirmation of the completion of the research project from the host research organisation
- Proof of health insurance coverage
- Proof of researcher’s intention to set up a business related to his/her field of research (if applicable)
